AN ACT to encourage the destruction of Bears, Wolves, Wild-cats and Loup-cerviers.

And said Treasurer on present-treasurer to ing to the Legislature his account, verified by oath present his account or affirmation, for the money paid by him as afore-lature, &c. said, shall be allowed the amount of such account from the Treasurers of towns and plantations, Duty of Treasurers of towns and plantations, Duty of Treasurers or loup-cervier as aforesaid, immediately, to destroy the same; and also carefully to preserve all affidavits received by him with the heads of animals as aforesaid.

AN ACT to repeal An Act respecting Alewives in certain streams in the town of Penobscot.

Be it enacted by the Senate and House of Representatives, in Legislature assembled, That an Act entitled "an Act to regulate the taking of alewives in Winslow's stream and Leach's stream in the town of Penobscot," passed the sixteenth day Act passed 16th of February one thousand eight hundred and twenty of Feb. 1828—eight, be and hereby is repealed.
