### Chapter 95.

Resolve in favor of James Pribble.

Approved March 9, 1832.

Resolved, That there be allowed and paid out of the Treasury of this State to James Pribble the sum of five dollars and ninety five cents, for labor in stone-cutting on the Public Buildings at Augusta in the year one thousand eight hundred and thirty.

## Chapter 96.

Resolve relating to land in Township No. 5, 2d Range North of the Million Acres, East of Penobscot River.

Approved March 9, 1822.

Resolved, That the Land Agent be, and hereby is authorized and directed to release by deed of quitclaim, to Eliashib Adams and Asa Davis of Bangor, the right, title and interest of the State, in and to the surplus quantity of land within the half township of land originally granted to Foxcroft Academy, and within the lines and boundaries as surveyed and now held by them, the said Adams and Davis. amounting by estimation to two thousand two hundred and two acres, agreeably to the award and determination of Allen Gilman and Thomas A. Hill, to whom with James Crosby, the question was referred.—Provided, that the said Adams and Davis, perform on their part, the award of the said Referees, viz. pay to the State Treasurer, for the use of the State, the sum of one thousand one hundred and one dollars, in the following manner—one fourth of said sum with interest annually, in each of the four succeeding years from the date of said award, which was the twentieth of September one thousand eight hundred and thirty one.

Provided, that the said conveyance by the Land Agent, shall be made whenever said Adams and Davis shall furnish and deliver to said Treasurer before the first day of September next, their notes with good and sufficient sureties to the acceptance of said Treasurer for the said sums, and payable at the times specified as aforesaid.

## Chapter 97.

Resolve in favor of Samuel Seavey and Thomas Trundy.

Approved March 9, 1832.

Resolved, That for reasons set forth in the petition of Samuel Seavey and Thomas Trundy, both of Wiscasset in the County of Lincoln, there be paid out of the State Treasury, to said Seavey the sum of one hundred and ninety two dollars and fifty cents, and to the said Trundy the sum of forty-six dollars. The aforesaid sums being severally allowed them, for supporting one John Wheeler, an insane person in Wiscasset Gaol, while they were Keepers of the same. Said sums to be in full of all claims either of them have on the State for said Wheeler's support up to February sixth, eighteen hundred and thirty-two. And the Governor with consent of Council, is hereby authorized to draw his warrant on the Treasury, in favor of the said Seavey and Trundy for the aforesaid several sums.

## Chapter 98.

Resolve in favor of Abner B. Thompson.

Approved March 9, 1832.

Resolved, That there be allowed and paid out of the Treasury, to Abner B. Thompson, late Treasurer of State, the sum of three dollars and eighty three cents in full for articles furnished by him for the use of the State, which were omitted to be entered on his last account.
