second range of townships North of Bingham's Penobscot Purchase, a grist mill and saw mill and have the same completed and in operation by the first day of October next, to convey to such person by deed a parcel of land not exceeding one hundred and sixty acres in said South half of said Township which may be owned by the State, when the contract, shall be made, for building said mills.

### Chapter 17.

Resolve in favor of Israel Davis and Jacob M. Russell.

Approved February 7, 1833.

*Resolved*, That, for reasons set forth in the petition of said Davis and Russell, the Land Agent be, and he hereby is, authorized and required to convey to said Davis and Russell, their heirs and assigns, in fee simple, the lot of land number Three in Township number Ten in the County of Washington, according to the survey of John Webber in the year one thousand eight hundred and thirty one, said lot containing two hundred and one acres more or less. *Provided*, said Davis and Russell shall before such conveyance give a bond in the sum of One Thousand Dollars to the State of Maine, with a surety or sureties, sufficient in the opinion of the Land Agent, conditioned for building, erecting and finishing on said lot a good and sufficient saw mill by or before the first day of October one thousand eight hundred and thirty three, and a good and sufficient grist mill by or before the first day of January one thousand eight hundred and thirty five, and keeping said mills in good repair for the term of eight years from the time of their erection.

### Chapter 18.

Resolve respecting Land in the Isle of Holt.

Approved February 7, 1833.

*Resolved*, That in consideration of the sums heretofore paid for the use of the State by the persons herein named,

the Land Agent be, and he hereby is, authorized and required to convey to them several lots of land in the Great Isle of Holt, viz: to Nathaniel Sawyer, the lot numbered thirty two; to Benjamin Merithew, lot numbered twenty seven; to Joseph Knowlton, the lots numbered seventeen and thirty; to Robert Knowlton, the lot numbered ten; to George Smith, the lots numbered fifteen, twenty five and twenty six; to Pelatiah Barter, the lot numbered thirty five; and to Chauncey Holmes, the lots numbered eighteen and nineteen.

*Resolved*, That the Land Agent is hereby authorized to sell all the land belonging to the State of Maine on the Great Isle of Holt, on such terms as to price and pay day, as he may judge just and reasonable.

### Chapter 19.

Resolve for the benefit of David Sevey.

Approved February 9, 1833.

*Resolved*, That there be paid annually, out of the Treasury of the State, to David Sevey, the sum of Six Dollars per month, commencing on the first day of March next and continuing during the pleasure of the Legislature, it being on account of a severe injury, received by him in the performance of military duty.

### Chapter 20.

Resolve respecting the records of the Commissioners under the "Act relating to the Separation of the District of Maine from Massachusetts proper, and forming the same into a separate and independent State."

Approved February 9, 1833.

*Resolved*, If the Commonwealth of Massachusetts shall herein concur, that the records of the doings of the Commissioners appointed pursuant to the first section of the "Act relating to the separation of the District of Maine from Massachusetts proper and forming the same into a
