## RESOLVES

OF THE

### THIRTEENTH LEGISLATURE

OF THE

## STATE OF MAINE,

#### PASSED AT THE SESSION

WHICH COMMENCED ON THE SECOND DAY OF JANUARY, AND ENDED ON THE FOURTH DAY OF MARCH, ONE THOUSAND EIGHT HUNDRED AND THIRTY-THREE.

the Land Agent be, and he hereby is, authorized and required to convey to them several lots of land in the Great Isle of Holt, viz: to Nathaniel Sawyer, the lot numbered thirty two; to Benjamin Merithew, lot numbered twenty seven; to Joseph Knowlton, the lots numbered seventeen and thirty; to Robert Knowlton, the lot numbered ten; to George Smith, the lots numbered fifteen, twenty five and twenty six; to Pelatiah Barter, the lot numbered thirty five; and to Chauncey Holmes, the lots numbered eighteen and nineteen.

Resolved, That the Land Agent is hereby authorized to sell all the land belonging to the State of Maine on the Great Isle of Holt, on such terms as to price and pay day, as he may judge just and reasonable.

## Chapter 19.

Resolve for the benefit of David Sevey.

Approved February 9, 1833.

Resolved, That there be paid annually, out of the Treasury of the State, to David Sevey, the sum of Six Dollars per month, commencing on the first day of March next and continuing during the pleasure of the Legislature, it being on account of a severe injury, received by him in the performance of military duty.

## Chapter 20.

Resolve respecting the records of the Commissioners under the "Act relating to the Separation of the District of Maine from Massachusetts proper, and forming the same into a separate and independent State."

Approved February 9, 1833.

Resolved, If the Commonwealth of Massachusetts shall herein concur, that the records of the doings of the Commissioners appointed pursuant to the first section of the "Act relating to the separation of the District of Maine from Massachusetts proper and forming the same into a

separate and independent State," and of the surveys made by their order, the journals, documents and papers relating to their proceedings, be deposited in the Land Office of the State of Maine in the State House in Augusta, to be there safely kept under the care of the Land Agents of Massachusetts and Maine, subject to the joint order of the two States.

### Chapter 21.

Resolve for the benefit of Heman Nye.

Approved February 9, 1833.

Resolved, That instead of the monthly sum, now allowed to Heman Nye, on account of an injury sustained by him in the performance of military duty, there shall be allowed to him a pension of Four Dollars per month, payable out of the Treasury of the State annually, to be computed from the first day of January one thousand eight hundred and thirty three, and continue during the pleasure of the Legislature.

## Chapter 22.

Resolve in favor of the Warden of the State Prison.

Approved February 10, 1833.

Resolved, That the Governor, with advice of Council, be authorized to draw his warrants on the Treasury, in favor of the Warden of the State Prison, for such sums as may be thought proper, not exceeding Seven Thousand Dollars, to meet such liabilities as said Warden may have incurred, for the use of said Prison, in consequence of not having received the amounts due on account of the notes given to him by Ira Norris and Foster Bryant; and that said Warden be, and he hereby is, required to pay into the Treasury all sums he may receive on account of said notes, until the amount so advanced therefrom with interest shall be refunded.
