### Chapter 55.

Resolve in favor of Samuel Call and John Wilkins.

Approved February 27, 1833.

*Resolved*, That the Land Agent be, and he is hereby authorized and directed to refund to Samuel Call and John Wilkins Thirty Five Dollars, it being for a deficiency in quantity of land, purchased by them of the State, in the year eighteen hundred and twenty five, situate in plantation numbered four on the East side of Penobscot river, estimated at the average price paid therefor and the interest thereon.

### Chapter 56.

Resolve for ascertaining the expense of making and repairing Roads and Bridges within this State.

Approved February 27, 1833.

*Resolved*, That the Selectmen of the several towns and the Assessors of the several plantations and the Mayor of the city of Portland be required to transmit to the Secretary of State, on or before the first day of October next, a statement of the sums expended in labor and in cash, in making, repairing and maintaining Roads and Bridges therein, during four years, commencing on the first day of January one thousand eight hundred and twenty nine, and ending on the thirty first day of December one thousand eight hundred and thirty two, and what price was allowed for labor, upon an average during said term.

*Resolved*, That the Secretary of State be required seasonably to transmit copies of these Resolves to the said Selectmen, Assessors and Mayor, together with blank forms for the returns aforesaid.

*Resolved*, That the Secretary of State be required, after said returns shall have been received, to make a list thereof by Counties, specifying, in separate columns, against the respective names of said towns, plantations and City the amount expended, during said four years, in cash, the amount expended in labor and the average price allowed for labor, and cause five hundred copies thereof to be printed and laid before the next Legislature, at the commencement thereof, for the use of the members.
