PASSED AT THE SESSION

Chapter 71.

An additional Resolve, providing for the appointment of a person to take care of the Military property of the State in Portland.

Approved March 2, 1833.

Resolved, That instead of the sum now allowed to the person appointed under the Resolve aforesaid, passed the first day of April one thousand eight hundred and thirty one, there shall be allowed and paid to him or to the person who may be appointed in his stead, as a full compensation for the services, which he may hereafter render under said appointment, the sum of Three Hundred and Twenty Five Dollars annually, to be paid out of the Treasury of the State.

Chapter 72.

Resolve in favor of Daniel Libby.

Approved March 2, 1833.

Resolved, That there be allowed and paid out of the Treasury of the State, to Daniel Libby, the sum of Two Dollars, in full compensation for his services, in watching the State Buildings by night.

Chapter 73.

Resolve laying a Tax on the several Counties in this State.

Approved March 2, 1833.

Resolved, That the sums annexed to the several Counties contained in the following Schedule be and the same are hereby granted as a Tax for said Counties, respectively, to be apportioned, assessed, collected and applied for the

purpose of paying the debts and necessary expenses of the several Counties in the manner required by law.

County of York, Seven Thousand Dollars.

- " Cumberland, Twelve Thousand, Two Hundred and Twenty Five Dollars.
- " Lincoln, Six Thousand and Nine Hundred Dollars.
- " Kennebec, Nine Thousand Dollars.
- " Oxford, Three Thousand Dollars.
- " Somerset, Four Thousand Dollars.
- " Waldo, Four Thousand Dollars.
- " Penobscot, Nine Thousand and Six Hundred Dollars.
- " Hancock, Three Thousand Dollars.
- " Washington, Four Thousand Four Hundred and Eighty Five Dollars.

Chapter 74.

Resolve in favor of the Westbrook Seminary.

Approved March 2, 1833.

Resolved, That there be, and hereby is granted to the Westbrook Seminary, the sum of One Thousand Dollars, payable as follows, viz. Five Hundred Dollars on the first day of April next, and Five Hundred Dollars on the first day of April in the year of our Lord one thousand eight hundred and thirty four.

Chapter 75.

Resolve providing compensation to Chaplains of the Legislature.

Approved March 2, 1833.

Resolved, That there be allowed and paid out of the Treasury of this State to Rev. Benjamin Tappan, Rev. Lemuel Porter, Rev. Joseph Underwood, Rev. Allen Put-
