#### CHAPTER 488.

AN ACT to annex Chandlers Gore to Livermore.

Approved March 7, 1834.

SECT. 1. Be it enacted by the Senate and House of Representatives, in Legislature assembled, That the unincorporated tract of land situated between the towns of Livermore and excepting North Hartford in the County of Oxford, known by the name of lot annexed to Livermore. Chandlers Gore (excepting the north lot thereof, owned by Messrs. Crooker and Rich) together with the inhabitants thereon, be and the same hereby are annexed to said
