FOURTEENTH LEGISLATURE

PASSED AT THE SESSION

WHICH COMMENCED ON THE FIRST DAY OF JANUARY, AND ENDED ON
THE THIRTEENTH DAY OF MARCH, ONE THOUSAND EIGHT
HUNDRED AND THIRTY-FOUR.

Chapter 68.

Resolve in favor of John Potter.

Approved March 12, 1834.

Resolved, That there be allowed and granted to John Potter for drafting Bills and Resolves, the sum of Three Dollars per day from the sixteenth day of January eighteen hundred and thirty four to the close of the present session of the Legislature, inclusive, in full for his services therefor.

Chapter 69.

Approved March 12, 1834.

WHEREAS it has been represented to this Legislature that the proprietors of the First Cumberland Turnpike Corporation within the town of Scarborough have received in tolls, such amount as that, by the terms and condition of the Charter, the franchise ought now to revert to the State.

Therefore, *Resolved*, That the Attorney General of the State be directed to cause a suitable process to be instituted against said proprietors to shew cause why they should continue to receive tolls upon said Turnpike, and why the said Turnpike and the franchise thereof should not revert to, and be vested in, the State.

Chapter 70.

Resolve authorizing the appointment of a Superintendent of the Public Buildings.

Approved March 12, 1834.

Resolved, That the Governor with the advice of Council be and he hereby is authorized and required to appoint some suitable person to take charge of the Public Buildings, and the property in the Representatives Hall, Senate Chamber and the several Committee Rooms during the recess of the Legislature; and of the Public Grounds, fences and forest trees during the year,—whose duty it shall be to preserve all the property before mentioned, and

daily to open and ventilate the several apartments in said buildings and to keep the same well swept and cleansed and personally to attend at seasonable hours, all visitors who may wish to view the same—and the said Superintendent shall not be allowed to hire a substitute except by the consent of the Governor and Council or during the recess of the Governor and Council, by the consent of the Secretary of State.

Resolved, That the person so appointed shall give a bond to the State, in the sum of One Thousand Dollars for the preservation of said property (a schedule of which shall be made and filed in the Office of the Secretary of State) and for the faithful performance of his duty and for his services he shall receive a sum not exceeding Two Hundred Dollars to be allowed and paid by the Governor and Council.

Chapter 71.

Resolve in favor of William V. and Oliver Moses.

Approved March 12, 1834.

Resolved, That there be paid out of the Treasury of this State, to William V. & Oliver Moses, of Bath, in the County of Lincoln, the sum of Seventy Dollars—the aforesaid sum being the balance due them for copper and iron work upon the State House, which sum is to be in full for the same.

Chapter 72.

Resolve authorizing a loan in behalf of the State.

Approved March 12, 1834.

Resolved, That the Governor with the advice of Council, be and hereby is, authorized to procure a loan of Ten Thousand Dollars at a rate not exceeding five per cent. per annum, payable at the pleasure of the State—that the same be applied to extinguish in part the debt due to the Central Bank.
