**Chapter 36.**

Resolve in favor of St. Albans Academy.

Approved March 14, 1837.

**RESOLVED**, That there be paid out of the Treasury of the State to the Treasurer of St. Albans Academy, the sum of Two Hundred Dollars, annually, for two years, commencing on the first day of January, in the year of our Lord one thousand eight hundred and thirty-seven; And the Governor with advice of Council, is hereby authorized to draw his warrants on the Treasurer for the same.

**Chapter 37.**

Resolve for making a Road from H. G. O. Barrows' in the town of Wilson to Moose Head Lake.

Approved March 14, 1837.

**RESOLVED**, That there be and hereby is appropriated the sum of Five Hundred Dollars for the purpose of opening and making a road from H. G. O. Barrows' in the town of Wilson in the County of Somerset to the foot of Moose Head Lake, on the route laid out by the County Commissioners for said County in May last. *Provided*, The Commonwealth of Massachusetts shall appropriate a like sum of Five Hundred Dollars and also *Provided*, That individuals shall pay or secure the payment of a like sum of Five Hundred Dollars, to the Agent of the State to be appointed for that purpose as is hereinafter provided.

**RESOLVED FURTHER**, That the Governor with advice of Council be, and he hereby is, authorized and empowered to appoint an Agent to superintend the opening and constructing of said road, who shall give bond to the Treasurer of State in the sum of Two Thousand Dollars for the faithful performance of his duties, shall receive all securities given and sums paid by individuals, for the purpose aforesaid, shall keep a true account thereof, shall faithfully expend all sums received by him in his said capacity, or

so much thereof as may be necessary in opening and constructing said road and shall render up and settle his accounts with the Governor and Council whenever thereunto required.

RESOLVED FURTHER, That whenever satisfactory evidence shall be furnished to the Governor and Council that the Commonwealth of Massachusetts has appropriated the sum of Five Hundred Dollars, and that individuals have paid or secured the payment of the sum of Five Hundred Dollars to said Agent to be by him expended as aforesaid, the Governor be, and he hereby is, authorized and empowered to draw his warrant on the Treasurer of State, for the sum of Five Hundred Dollars, to be paid to the aforesaid Agent as provided by the preceding Resolves.

### Chapter 38.

Resolve in favor of James Lawrence.

Approved March 14, 1837.

RESOLVED, That there be paid out of the Treasury of the State—to James Lawrence, of Newport a pension of Four Dollars per month for two years; commencing on the first day of January eighteen hundred and thirty-seven, in consideration of an injury sustained by him while performing military duty.

### Chapter 39.

Resolve in favor of William Frye.

Approved March 15, 1837.

RESOLVED, That there be paid out of the Treasury of the State of Maine, from any monies not otherwise appropriated, the sum of Twenty Five Dollars, to William Frye of Bethel, for his services as School Commissioner, under the Resolve of March twenty-fourth, eighteen hundred and thirty-five.
