

## RESOLVES

#### OF THE

### EIGHTEENTH LEGISLATURE

#### PASSED AT THE SESSION

WHICH COMMENCED ON THE THIRD DAY OF JANUARY, AND ENDED ON THE TWENTY-THIRD DAY OF MARCH, ONE THOUSAND EIGHT HUNDRED AND THIRTY-EIGHT.

PUBLISHED AGREEABLY TO THE RESOLVE OF JUNE 28, 1820.

#### CHAPTER 69.

Resolves requesting our Senators and Representatives in Congress to investigate the manner and circumstances of the death of Jonathan Cilley.

#### Approved March 22, 1838.

RESOLVED, (the Senate and House concurring,) That the investigation into the manner and circumstances of the death of Jonathan Cilley, late a member of Congress from this State, instituted by the House of Representatives in Congress, was demanded by the people of this State; and our Senators and Representatives in Congress be requested to use their efforts to prevent any abandonment of the said investigation, until all the facts and circumstances are ascertained and reported.

RESOLVED, That if any member or members of either House of Congress shall be implicated in any conspiracy which led to the violent death of the said Jonathan Cilley, it will become the imperative duty of Congress to expel such member or members.

**RESOLVED**, That we entertain no other than sentiments of deep and unqualified abhorrence of that cruel and sanguinary code which so often selects its victims from among the brightest and worthiest of the land, and that we call upon our Senators and Representatives in Congress to give their united support to the establishment of such laws, legislative and conventional, as may prevent the recurrence of such melancholy events as that which has recently clothed our State in sorrow.

#### CHAPTER 70.

Resolve authorizing the distribution of the Second Report on the Geology of Maine.

Approved March 22, 1838.

RESOLVED, That there shall be copies of the Second Re-

port of the Geological Survey of Maine distributed in the following manner, viz:-Twelve copies to the Governor of the State, one copy to each member of the Council, Senate and House of Representatives, one copy to the Secretary of State, Treasurer, Land Agent and Adjutant General, one copy to the Secretary, Assistant Secretary, and Messengers of the Senate, one copy to the Clerk, Assistant Clerk and the Messengers of the House, one hundred copies to the Governor and Council to be by them distributed, two copies to each of the Cities, Towns and organized Plantations, two copies to each of the Colleges in this State, one copy to the Bangor Theological Institution at Bangor, one copy to each of the incorporated literary Institutions and Academies in the State, one copy to the Maine Medical School, one copy to the Maine Historical Society, one copy to the Maine Institute of Natural Science, one copy to each of the incorporated Agricultural Societies in the State, one hundred copies to the Geological Surveyor, three copies to each of his Assistants, and three to the Draftsman, five copies to the Library of the State, one copy to each of the Clerks in the several Departments of this State, one copy to the Executive of each State in the Union, one copy to each of the Colleges in New England except those in this State, one copy to the American Academy of Arts and Sciences, one copy to the Antiquarian Society in Worcester, (Mass.) two copies to the Library of the United States, one copy to the Surveyor General of this State, one copy to each Chaplain of the Senate and House of Representatives, two copies to the President of the United States, one copy to the Secretary of State of the United States, one copy to the Secretary of the Treasury of the United States, one copy each to the Secretary of War and of the Navy, one copy to the Post Master General, and one copy to each member of Congress. And the remainder of the edition of Reports shall be equally divided among the Senators and Representatives, to be by them distributed among the people in their several School Districts, or otherwise, according to their discretion.

**RESOLVED**, That the Secretary of State be directed to forward the copies aforesaid, to the several Cities, Towns and Plantations, Members of Congress and to all others, except Members of the Council, Senate and House of Representatives.

**RESOLVED**, That the Secretary of State be directed to forward one copy of the first report of the Geological Survey of Maine, to each member of Congress, provided there shall be a sufficient number of copies remaining in the Secretary's Office.
