## CHAPTER 71.

Resolve for the payment of Accounts against the State.

Approved March 22, 1838.

RESOLVED, That there be allowed and paid from the Treasury of the State, out of any money not otherwise appropriated, to the several persons, cities, towns and plantations, mentioned in Roll of Accounts, No. 19, the sums set against the names of persons, cities, towns and plantations, respectively, amounting in the whole, to the sum of Twenty-four Thousand, Thirty-seven Dollars and Ninety-nine Cents, in full discharge of the Accounts and demands to which they refer.

## CHAPTER 72.

Resolve in favor of Greenleaf Kiff and others.

Approved, March 23, 1838.

RESOLVED, That there be allowed and paid from the Treas-

ury of the State to the several persons hereinafter named the sums of money set against their respective names, to wit: to Greenleaf Kiff the sum of Thirteen Dollars, to Charles B. Weatherbee, Thirteen Dollars, it being for their travel and attendance to and at Augusta the present winter as witnesses in case of the contested election of Gideon Richards, a member of the House of Representatives:—to Bartholomew G. Greer, Daniel Robinson Jr., David Daniels, Aaron Edgcomb, and Isaac Ordway the sum of One Dollar and Eleven Cents each, it being for their legal fees as deponents in said case, and to Nathl. M. Lowney the sum of Seven Dollars and Fifty Cents it being for his legal fees as a Justice of the Peace in taking depositions in said case. And the Governor is hereby requested to draw his warrant upon the Treasurer in favor of Gideon Richards for the sum of Thirty-nine dollars and Five Cents, being the amount of the several sums aforesaid, to be by said Richards duly accounted for to the several persons aforesaid.

#### CHAPTER 73.

Resolve in relation to Oxford Bank.

Approved March 23, 1838.

RESOLVED, That there is not, and never has been any such Institution in this State as the Oxford Bank—that the issuing of Bills, purporting to be Bills of such Bank was a gross fraud on the public, and the projectors of that swindling scheme are totally unworthy of the confidence of the community, and should be made to suffer the most rigid penalties of the law for the punishment of such offenders made and provided.

#### CHAPTER 74.

Resolve for building a bridge across Moose River.

Approved March 23, 1838.

RESOLVED, That there be and is hereby appropriated the sum of Seven Hundred and Fifty Dollars for the purpose of building a bridge across Moose River, on the Canada Road,
