CHAPTER 91.

Resolve in favor of the Town of Otisfield.

Approved March 23, 1838.

RESOLVED, That there be allowed and paid from the Treasury of this State to the Treasurer of the Town of Otisfield, Twenty Dollars, it being a mistake on the Bounty on Wheat in said Town.

CHAPTER 92.

Resolve in favor of Charles Gellerson.

Approved, March 23, 1838.

RESOLVED, That there be paid out of the Treasury of this State, to Charles Gellerson, of Fowler Gore, in the County of Washington, the sum of Seven Dollars and Forty Cents, it being a Bounty on Wheat raised by him during the year one thousand eight hundred and thirty-seven.

CHAPTER 93.

Resolve authorizing the Land Agent to procure certain plans from the Land Officer in Massachusetts.

Approved March 23, 1838.

RESOLVED, That the Land Agent be authorized and directed to procure from the Land Officer in Massachusetts, at the expense of the State an attested copy of all the plans and surveys of Islands situated in this State—also a Schedule of all the Islands sold by the Commonwealth of Massachusetts designating the date of each sale and the names of the respective purchasers, and deposite the same in the Land Office—Provided, however, that the expense shall not exceed the sum of Seventy-five Dollars.
