Chapter 504.

AN ACT to change the names of certain persons.

Approved February 6, 1839.

Be it enacted by the Senate and House of Representatives in Legislature assembled, That Joshua Waterhouse of Portland, be allowed to take the name of Joshua Milliken Waterhouse; that John Treworgy of Ellsworth, be allowed to take the name of John True; that John Greenleaf Cloutman, Jane Cloutman, Elizabeth Cloutman and Charles Cloutman of Portland, be severally allowed to take the name of Greenleaf for their surnames; that Jefferson Whitehead of Paris, be allowed to take the name of Thomas Jefferson Whitehead; that Deborah Gilman of Portland, be allowed to take the name of Mary Grant; that Thomas B. Gibbs, Sylva Gibbs, wife of said Thomas and their children, viz: Francis A. Gibbs, Sarah E. Gibbs, and Thomas B. Gibbs Jr. of Waterville, be allowed to take the name of Blakewell, for their surnames; that Israel Record of Paris, be allowed to take the name of Charles Hall; that Simeon Woodard of Gardiner, be allowed to take the name of George Simeon Woodard; that Samuel Milliken of Seaville, be allowed to take the name of Samuel Franklin Milliken; that Benjamin Franklin Vose of Augusta, be allowed to take the name of Frank Vose; that Martha Caroline Willis of Litchfield, be allowed to take the name of Martha Caroline Willis Neal; that Joseph Woodman of Searsmont, be allowed to take the name of Joseph Lambert Woodman; that Joseph Hatch 3d, of Kennebunk, be allowed to take the name of Joseph E. Hatch; that John Young of Bangor be allowed to take the name of John L. Young; that Andrew Soule of Freeport be allowed to take the name of Andrew Jackson Soule; that Alfred Jones Stone Morse of Brunswick, be allowed to take the name of William Hunt Morse, Jr.
