RESOLVED, That it shall be the duty of the Secretary of State to cause a sufficient number of copies of the abstract and statements aforesaid to be printed, and to forward by mail, or otherwise, to the Aldermen of the several cities, Selectmen of the several towns, and Assessors of the several plantations one copy for each School District within such city, town or plantation. And such Aldermen, Selectmen and Assessors are hereby required, as soon as may be, on the receipt of such Abstracts, to distribute one copy thereof to each School District within such city, town or plantation.

Chapter 79.

Resolve declaring the Charter of the Bank of Old Town forfeit and void.

Approved March 20, 1839.

RESOLVED, That the President, Directors and Company of the Bank of Old Town, not having complied with the laws regulating Banks and Banking, and having failed to redeem their bills; the Charter of said Bank is hereby declared "forfeit and void," except for the purpose of closing up the business of the institution.

Chapter 80.

Resolve in favor of the Counties of Franklin, Piscataquis and Aroostook.

Approved March 20, 1839.

RESOLVED, That the Secretary of State be and he hereby is directed to furnish the Clerks of the Courts for the Counties of Franklin, Piscataquis and Aroostook, with

full sets of the Public and Private Laws and Resolves of the State, and with all the Maine Reports. And the Treasurers and Judges of Probate of said Counties with full sets of the Public and Private Laws and Resolves; and the Sheriffs, Prison Keepers, Registers of Deeds, and Registers of Probate with full sets of the Public Laws of the State. And the books aforesaid shall be the property of the several Counties and shall be delivered over by the officers aforenamed to their successors in office.

Chapter 81.

Resolve for the repair of the Gun House in Farmington.

Approved March 20, 1839.

RESOLVED, That there be and hereby is appropriated the sum of one hundred dollars to be expended under the direction of the Governor and Council for the purpose of repairing the Gun House in Farmington.

Chapter 82.

Resolve in favor of John Freese.

Approved March 20, 1839.

RESOLVED, That the Land Agent be and hereby is authorized and directed to make and execute to John Freese, in behalf of the State, a deed of river lot numbered two, in township numbered two, Old Indian Purchase, now Greenbush, in the County of Penobscot, containing one hundred acres, more or less, at any time within thirty days, *Provided* that the said Freese shall pay into the Land Office the sum of One Hundred Dollars.
