printed list; and it shall be the duty of the Secretary of State to require any bank, which may neglect to make the returns required by law to the Legislature, to furnish him forthwith with a list of the stockholders of such bank and also, the amount of stock owned by each stockholder.

### Chapter 86.

Resolve for furnishing incorporated towns and organized plantations with Books.

*Approved March 21, 1839.*

WHEREAS, There are several incorporated towns and plantations in this State which have not received their equal proportions of books with other towns in said State, and whereas, there is not a sufficient number of books now in the Secretary's office to furnish said towns, therefore,

RESOLVED, That the Secretary of State be, and is hereby authorized to furnish at the expense of said State such additional copies of books, maps, or documents as have heretofore been furnished other towns and plantations.

RESOLVED, That in order to carry the foregoing Resolve into effect there be, and hereby is, appropriated the sum of five hundred dollars, and the Governor, with advice and consent of the Council, is hereby authorized to draw his warrant on the Treasurer of State, from time to time in favor of the Secretary of State, for such sums as may be deemed necessary for the purchase of any books, maps and other documents contemplated by the foregoing Resolve.

### Chapter 87.

Resolve in relation to the Field in front of the State House.

*Approved March 21, 1839.*

RESOLVED, That from and after the passage of this Resolve, the Superintendant of the Public Buildings be authorized and required, under direction of the Governor,

to lease the ground in front of the State House, east of the Hallowell road, for a term not exceeding five years, to some suitable person or persons who will give a sufficient bond to the State to the acceptance of the Governor, conditioned that he or they will cause said grounds to be cultivated in a husbandlike manner by ploughing, planting and thoroughly manuring for at least the first three years of the term, and at the termination of the lease to surrender the premises to the State, well laid down to grass.

### Chapter 88.

Resolve in favor of the Insane Hospital.

*Approved March 21, 1839.*

RESOLVED, That there be allowed and paid out of the Treasury, the sum of Fifteen Thousand Dollars to discharge present legal liabilities and to finish one wing of the Insane Hospital, with so much of the central building, as may be necessary for its convenient occupation, and the Governor, with advice of Council is hereby authorized to draw his warrant on the Treasury for the same.

### Chapter 89.

Resolve in favor of Joseph Pomroy.

*Approved March 22, 1839.*

RESOLVED, That there be paid out of the Treasury of this State, to Joseph Pomroy of Levant, the sum of Four Dollars per month for one year, it being in consequence of a wound received by him while in the service of the State.
