### Chapter 119.

*Approved March 23, 1839.*

Resolve on the Pay Roll of the Senate.

RESOLVED, That there be paid to the several persons named in the above and preceding Roll, the sum set against their names respectively, amounting, in the whole, to the sum of five thousand six hundred and fifty-eight and a half dollars.
