Chapter 5.

Resolve authorizing the County Commissioners of Aroostook County to hire money, for and on the faith of said County.

Resolved, That the County Commissioners of Commissioners the County of Aroostook be and they are hereby to amount of authorized to borrow on the faith and responsibility \$3,000. of said County, to meet the current expenses thereof such sum or sums of money as they may deem necessary not exceeding three thousand dollars, to be reimbursed within three years from the passage of this Resolve.

Chapter 6.

Resolve authorizing a Loan in behalf of the State.

Resolved, That the Treasurer be, and he hereby is authorized to procure on the faith of the State Loan, 6 per cent, a loan not exceeding two hundred thousand dollars 20 yrs., \$200,000 reimbursable at such times as in his opinion shall be most advantageous to the State, but not beyond the period of twenty years, at a rate of interest not exceeding six per cent. per annum, payable annually Payable at the at the Treasury or in the cities of Boston and New Treasury or cities of Boston or N.
