Chapter 78.

Resolve authorizing the payment of interest on the temporary loan, approved February 15, 1839.

Resolved, That the Treasurer of State be and Treasurer directive he hereby is authorized and directed to pay the on the temporary loan. interest of the temporary loan, authorized to be made by Resolve, approved February fifteenth, 1839, annually, until the repayment of the principal.

Chapter 79.

Resolve making appropriations of land for officers and soldiers of the Revolution, and their widows.

Resolved, That township numbered eight in the third range of townships west from the east line of State, in the County of Aroostook, is hereby approlutionary gollutionary gollution priated in lieu of township letter D. in the first range, to satisfy the holders of certificates for land, issued by the Land Agent, under Resolves approved March 17, 1835, March 20, 1838.—And Resolve additional, approved March 23, 1838, and under special Resolves referring thereto where the holders of certificates have not selected lots and received deeds, nor have had lots assigned for that purpose, and for satisfying claimants whose claims may hereafter be allowed by virtue of said Resolves, or for any subsequent special or general Resolve that may

Land Agent to assign the lots when surveyed, certificates respectively.

be passed, granting land to officers or soldiers of the Revolutionary war, or their widows:—and it is Land Agent to hereby made the duty of the Land Agent to cause No. 8, to be surveyed as soon veyed into lots of 200 acres each, as may be, into lots of two hundred acres each, to be numbered progressively from one, to the whole number of lots in the township, and as soon as may be convenient after the field notes and plan of said survey shall have been returned into the Land Office, it shall be the duty of the Land Agent, in the presence of three disinterested persons, to put the names to the holders of of persons holding certificates and entitled to land under said Resolves as aforesaid, into a box, and draw them out one at a time, and the first drawn name shall be entitled to lot number one, and each other name drawn shall be entitled to the lot lowest in number remaining undrawn in the township, and when the name of a person entitled to six hundred acres of land shall be drawn, he shall be entitled to the three lowest numbers undrawn; excepting in all cases the lots reserved for public uses.

Resolved, That a "Resolve making appropriation of land for officers and soldiers of the Revolution, and their widows," approved January 28, 1839, be and the same is hereby repealed.

Chapter 80.

Resolves for the distribution and safe keeping of the Laws and Reports.

Sec'y of State to furnish the Judges of Probate anives.

Resolved, That the Secretary of State, furnish the several Judges of Probate in this State with the the Laws, Reports and Resolves, providing it has with the Laws, not been done, and such as may hereafter be published, which shall be considered for the benefit of the office and shall be transferred to their several successors in office.
