Chapter 87.

Resolve on the Pay Roll of the Senate.

Resolved, That there be paid to the several persons named in the above and preceding Roll, the sum set against their names respectively, amounting in the whole, to the sum of five thousand three hundred and seven dollars.

[Approved March 18, 1840.]
