**Chapter 96.**

Resolve authorizing the Acting Quarter Master General to re-convey a lot of land in Limerick.

A. Q. M. General authorized to reconvey a lot of land.

*Resolved,* That the Acting Quarter Master General be, and he hereby is authorized to re-convey to John A. Morrill, of Limerick, a lot of land situated in the town of Limerick, which was conveyed to the State by said John A. Morrill, by his deed of January twenty-seventh, one thousand eight hundred and forty; and to execute a legal transfer of the State's right thereto.

**Chapter 97.**

Resolve in favor of the town of St. George.

Treasurer of State to pay certain notes on demand.

*Resolved,* That the Treasurer of State be, and is hereby authorized to pay to the town of St. George at the present time, the amount of two notes belonging to said town, and given for its proportion of the Surplus Revenue; the said notes being payable on the first day of February next.

[*Approved October 21, 1840.*]

**Chapter 98.**

Resolve relating to the Loans of this State.

Amount of loan changed from 450,000 to \$400,000.

*Resolved,* That the amount authorized to be borrowed under the Resolve, passed January 31, 1839, be limited to the sum of four hundred thousand dollars, instead of four hundred and fifty thousand dollars, as provided in said Resolve.

*Resolved*, That the amount authorized to be borrowed under the Resolve passed February 29, 1840, be eighty thousand dollars, instead of two hundred thousand dollars, as provided in said Resolve.

Amount of loan

200,000, to 80,000.

*Resolved*, That the amount authorized to be borrowed under the Resolve, passed March 7, 1840, be four hundred and seventy-five thousand dollars, instead of three hundred and fifty thousand as provided in said Resolve.

Amount of loan

### Chapter 99.

Resolve in favor of the town of Hebron.

*Resolved*, That there be paid out of the Treasury of the State, to the town of Hebron on the first day of January next the sum of seventy-two dollars and sixty-one cents, as an abatement of State tax assessed on said town for the year one thousand eight hundred and forty.

### Chapter 100.

Resolve in favor of the town of Orrington.

*Whereas* in the apportionment of the sum of three hundred five dollars and sixty-two cents upon the town of Orrington, in the State tax of the year one thousand eight hundred and forty, there is an over-assessment of twenty-two dollars and fifty cents occasioned by an error of ninety polls in the valuation of said town.
