ANDROSCOGGIN MAN'G CO.-MEETING-HOUSE.

regular duties.

appoint a suitable person, to officiate as chaplain of the State Prison, whose duty it shall be, to preach to the convicts two sermons, or perform other religious services equivalent thereto, each Sabbath in the year ; to visit the sick; to superintend the Sabbath school; and, daily during the week, by private conversation with the prisoners, to use his utmost efforts for their moral and religious improvement. He shall also, if opportunity may offer, at other times, instruct them in the rudiments of learning.

SECT. 6. Be it further enacted, That the salary of the chaplain of the State Prison shall be three hundred dollars per annum, instead of the salary now established by law; commencing on the first day of April, in the year of our Lord, one thousand eight hundred and forty-one.

Chapter 156.

AN ACT in addition to an Act incorporating the Androscoggin Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, That the An-Corporate name droscoggin Manufacturing Company shall have the Further limita benefit of the exemption provided in the second secital stock, actually paid in, shall amount to one hundred thousand dollars, on the same conditions, in other respects, as mentioned in the second section. Chapter 157.

AN ACT to authorize the proprietors of the first Baptist meetinghouse in Jefferson to dispose of the same.

be, and they hereby are authorized and empowered to sell said house, in such manner as they shall direct, $\frac{-as}{may}$ majority by a vote of a majority of said proprietors present at any legal meeting, called for that purpose by virtue of this Act. Chapter 158.

AN ACT to incorporate the Milo Starch Manufacturing Company.

SECTION 1. Be it enacted by the Senate and House of Representatives in Legislature assembled, That C. A. Everett, Daniel Dennett, C. G. Foss, Russell Corporators. Kittredge, Thomas Chase, S. W. Furber, W. S. Dennett, with their associates and successors, be, and they are hereby incorporated into a body politic, by the name of the "Milo Starch Manufacturing Company," Corporate name for the purpose of manufacturing starch in said town of Milo.

SECT. 2. Be it further enacted, That said corporators are hereby vested with all the rights, privi-^{Powers, &c.} leges and immunities, granted by existing laws to manufacturing corporations, and to hold real and per- Capital stock, sonal estate to an amount not exceeding three thousand ^{\$3,000.} dollars.

Chapter 159.

AN ACT additional to an Act to incorporate the Kennebec Ferry Company.

SECTION 1. Be it enacted by the Senate and House of Representatives in Legislature assembled, That 355
