Legislature, proposing to elect the Governor, members of the Legislature and other State officers for the term of two years, and that the Legislature shall meet once in two years?" "Shall the Constitution be amended by adopting the second resolve passed by the Legislature for the amendment of the Constitution, proposing that the number of representatives shall be established at one hundred and fifty-one?" And the ballots shall be given in separately upon each question, those in vote on each, by favor of either of said amendments voting "yes," and ballot, "yes," and ballot, "yes," those opposed voting "no," upon each amendment; and the ballots shall be received in separate boxes, be sorted, counted and declared, and lists made out of the votes, by the clerks, and returned to the office of Returns to be made to Secretary of State, in the same manner as votes State's office. for senators; and the Governor and Council shall gov. & Council count the same, and make return thereof to the next and make return Legislature, and if a majority of votes are in favor of to Legislature. either of said amendments, it shall become a part of the Constitution; and if there is a majority in favor of both, then both amendments shall become a part of the Constitution.

Resolved, That the Secretary of State shall prepare sec'y of state to and furnish the several cities, towns and plantations, &c. with blanks. blank returns in conformity to the resolves, accompanied with a copy of the resolves.

#### Chapter 182.

RESOLVE in favor of Isaac Hodsdon.

Resolved, That there be paid, out of the treasury of the State, to Isaac Hodsdon the sum of seventy-Isaac Hodsdon, eight dollars and seventy-eight cents, in full for money to New Brunse expended by him in traveling into the province of liberation of E. New Brunswick, in eighteen hundred and thirty-sev-s. Greeley. en, to obtain information relative to liberating Greeley from jail.
