Chapter 6.

Снар. 6.

AN ACT to extend the time allowed the Exchange Bank to close its concerns.

Be it enacted by the Senate and House of Representatives in Legislature assembled, [as follows:]

That a further time of one year from the sixth day of April, in Exchange Bank allowed one year the year of our Lord one thousand eight hundred and forty two, from April 6, 1842, to close its be allowed the Exchange Bank for the purpose of closing the concerns of said bank, in the manner provided in the act accepting the surrender of its charter, passed March seventh, one thousand eight hundred and forty.

[Approved February 12, 1842.]

Chapter 7.

AN ACT additional to an act accepting the surrender of the charter of the People's Bank, Bangor.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The powers and liabilities continued to the People's Bank, Ban- Powers and liagor, by the second section of an act, accepting the surrender of the of the charter of said bank, approved March twenty first, one thousand therefore the charter of the second section of the second section of the act of March 11,1838, extended a further time of two eight hundred and thirty eight, and further continued for the term of two years, by "an act additional to an act accepting the surrender of the charter of the People's Bank, Bangor," approved February seventeenth, one thousand eight hundred and forty, are hereby extended for the term of two years, from and after the twentieth day of March, in the year of our Lord one thousand eight hundred and forty two.

Chapter 8.

AN ACT additional to an act, entitled, "an act, to annex a part of Andover Surplus West, and Letter A, No. 2, to the town of Newry."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. From and after the passage of this act, the following described line shall be known and established as the true line between the said town of Newry and the said Surplus, and Letter A, Boundary be-No. 2, to wit: beginning on the line between said Surplus and the tween the town of Newry, Andotown of Andover, at the division line between ranges nine and ten, and Letter A, No. 2.

and thence running westwardly on said division line to said Letter A, No. 2; thence south nineteen degrees east, on the line between said Letter A, No. 2, and said Surplus, twenty eight rods; thence south sixty nine degrees west, about two hundred and fifty rods to the division line between lots, numbered eleven and twelve, in the thirteenth range of lots in said Letter A, No. 2; and thence south eight degrees west, on the said last mentioned line about five hundred rods to the old north line of said Newry.

Acts, &c. inconsistent, repealed

SECT. 2. All acts and parts of acts, inconsistent with the provisions of this act, hereby are repealed.

Chapter 9.

AN ACT to divide the town of Minot, and incorporate the easterly part thereof into a town by the name of Auburn.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Part of Minot set

SECT. 1. All that part of the town of Minot lying easterly of the curve line, so called, is, hereby set off from the town of Minot, and incorporated into a town by the name of Auburn; and the inhabitants thereof are hereby vested with all the powers, privileges and immunities, which the inhabitants of other towns in this State enjoy.

General powers.

Taxes and debts, how paid.

SECT. 2. The inhabitants of said town of Auburn shall be holden to pay the arrears of all taxes, which have been legally assessed on them, and of assessments which may have been voted by said town of Minot, together with their proportion of all the debts due from the said town of Minot, at the time this act shall take effect; and the said town of Auburn shall be entitled to receive and hold their proportion of the debts and taxes due to said town of Minot; said proportion to be ascertained by the last valuation of their respective towns.

How divided.

Of the support of paupers.

Sect. 3. All persons now chargeable as paupers to said town of Minot, shall be supported by the towns of Minot and Auburn in proportion to their valuation for the year one thousand eight hundred and forty. And all persons who may hereafter become chargeable as paupers, shall be considered as belonging to that town on whose territory they may have gained a legal settlement, and shall be supported by the same.

Powers of collectors of taxes. Sect. 4. The several collectors of taxes for the town of Minot, are hereby authorized and empowered to collect and pay all taxes
