CHAP. 29.

Chapter 29.

AN ACT to authorize the town of Bath to erect a bridge over New Meadows river, and to raise money to build and maintain the same.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Town of Bath authorized to build a bridge.
Location.

Construction.

Said town to control the same.

Liabilities.

May raise money.

SECT. 1. The town of Bath is hereby authorized to erect and maintain a free bridge over New Meadows river, from land of Robert Harding in Brunswick over Little Bullrock (so called) to land in Bath ; said bridge to be provided with a convenient draw sufficient for the passage of vessels on said river, and also to be built of good materials, substantially made, well railed, and convenient for the passage of travelers thereon.

SECT. 2. If the town of Bath shall erect and complete said bridge, the said town shall thereafter have the same control thereof, and be under the same liabilities to keep it in repair, as if it were wholly within the limits of said town ; and said town is authorized to raise money by taxation or otherwise, for the purpose of building and maintaining the same.

Chapter 30.

AN ACT to incorporate the Washington Hall Association.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Names of Corporators.

Corporate name.

Powers and liabilities.

May hold estate amounting to \$5,000.

Benjamin Wyman, Cyrus Fletcher, Abner Kirby, C. Dinsmore, Asa Wyman and Llewellyn Kidder with their associates and successors, are hereby constituted a corporation at Skowhegan in the county of Somerset by the name of the Washington Hall Association, with all the rights and liabilities prescribed in the seventy sixth chapter of the revised statutes, entitled "of corporations," and may raise funds to be employed for moral, literary and scientific purposes, and may hold real and personal estate to the value of one thousand dollars.
