## CHAP. 57.

## Chapter 57.

AN ACT supplementary to an act to apportion and assess a tax on the inhabitants of this state, passed March 18, 1842.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Taxes,  
Town of Clinton,  
\$473,03.

Sebasticook,  
\$331,44.

The town of Clinton shall be assessed and pay the sum of four hundred seventy three dollars and three cents, instead of eight hundred and four dollars and forty seven cents, as directed by said act; and the town of Sebasticook shall be assessed and pay the sum of three hundred and thirty one dollars, and forty four cents; and the treasurer of the state shall forthwith send his warrants directed to the selectmen or assessors of the respective towns of Clinton and Sebasticook, requiring them respectively to assess the sums aforesaid, in manner as directed by the aforesaid acts. And this act shall take effect from and after its approval by the governor.

## Chapter 58.

AN ACT to provide in part for the expenditures of government.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Appropriation of  
money for certain  
purposes.

Governor may  
draw his warrant  
prior to January  
1, 1843.

That in order to provide for the operation of certain acts and resolves of the legislature requiring the payment of money from the treasury; and also to provide for the necessary expenditures of government for the extra session of the legislature, the following sums be and the same are hereby appropriated to be paid out of any moneys in the treasury. And the governor with advice of council is hereby authorized at any time prior to the first day of January next, to draw his warrants on the treasurer of State for the same.

Miles Staples.	Miles Staples, ten dollars,	10 00
George W. Cummings.	George W. Cummings, eight dollars and ninety six cents,	8 96
Aggregate.	Amounting in the whole to ten thousand, two hundred and eighty one dollars and sixteen cents.	\$10,281 16
