CHAP. 8.**Chapter 8.**

Resolve in favor of Joseph Salmo and Sabattus Neptune.

J. Salmo and  
Sabattus Nep-  
tune, \$60.

*Resolved*, That the governor be requested to draw his warrant for sixty dollars, to be paid from the treasury of the state, in equal proportions to Joseph Salmo and Sabattus Neptune, agents of the Passamaquoddy tribe of Indians, for the purpose of defraying their expenses to and from the seat of government.

[*Approved February 4, 1842.*]

**Chapter 9.**

Resolve to pay the expense of certain Indians of the Penobscot tribe.

Joe Porus, Joe  
Socabeson and  
P. Newell, \$60.

*Resolved*, That the governor be requested to draw his warrant for sixty dollars to be paid from the indian fund, in equal proportions, to Joe Porus, Joe Socabeson and Peol Newell, for the purpose of defraying their expenses to and from the seat of government.

[*Approved February 7, 1842.*]

**Chapter 10.**

Resolve for furnishing towns and plantations with books and maps.

Secretary of  
state authorized  
to furnish certain  
towns and plan-  
tations with  
books and maps.

*Resolved*, That the secretary of state be, and he hereby is authorized and directed to procure and furnish, at the expense of the state, all newly incorporated towns and organized plantations, or such towns as may hereafter be incorporated, and such plantations as may hereafter be organized, with one of Greenleaf's or Deane's map of Maine, and all such books and documents as have heretofore been furnished other towns and plantations.

[*Approved February 9, 1842.*]

**Chapter 11.**

Resolve in favor of Sanford Kingsbery.

S. Kingsbery,  
\$500.

*Resolved*, That there be paid out of any money in the treasury not otherwise appropriated, to Sanford Kingsbery, the sum of five hundred dollars, for his services and responsibility as commissioner of loans, the past year.

[*Approved February 9, 1842.*]
