**Chapter 35.****CHAP. 35.**

Resolve, to authorize the Land Agent to settle with S. & W. H. Smith.

*Resolved*, That the land agent be authorized to settle with S. & W. H. Smith of Oldtown for lumber cut the present winter on township No. 8, range 13, at a fair and reasonable stumpage. *Provided*, said land agent shall be satisfied that said Smiths' entered upon said township without intent to defraud the state.

Land Agent authorized to settle with S. & W. H. Smith.

**Chapter 36.**

Resolve, authorizing the land agent to locate and open a road from the Aroostook to the St. John river.

*Resolved*, That the land agent of Maine, in concurrence with the land agent of the commonwealth of Massachusetts, be, and hereby is directed to extend the location and opening of the state road from the Aroostook river in township letter G, second range, in the most direct and best route, northerly, to the river St. John. And he is hereby authorized to expend thereon, in opening the same, a sum not to exceed one hundred dollars per mile, nor a greater sum than three thousand dollars on the whole. *Provided*, that the commonwealth of Massachusetts shall pay the expense of locating and making the said road over lands belonging to said commonwealth.

Land Agent authorized to locate a road from the Aroostook to the St. John.

Proviso.

[*Approved March 10, 1842.*]

**Chapter 37.**

Resolve directing the land agent to locate and subdivide certain lands.

*Resolved*, That the land agent be, and he is hereby authorized and directed, to cause to be extended the location of the seventh range of townships, west from the east line of the state, to the St. John river, and subdivide, and lot so much thereof for settlement, as the said agent may deem necessary and proper; *Provided*, the assent of the commonwealth of Massachusetts be had thereto.
