Extra Session, 1842.

CHAP. 113.**Chapter 113.**

Resolve in favor of Joseph Smith.

Joseph Smith.
§37 20.

Resolved, That there be paid out of the treasury of this state, to Joseph Smith of Cumberland, the sum of thirty seven dollars and twenty cents in full for his account as sheriff of the county of Cumberland for the year eighteen hundred and forty one.

[*Approved May 27, 1842.*]**Chapter 114.**

Resolve in favor of Miles Staples.

Miles Staples.
§10.

Resolved, That there be paid out of the treasury of the state to Miles Staples, the sum of ten dollars, it being the balance due him for services as adjutant of regiment of cavalry, second brigade, third division, for the year eighteen hundred and forty one.

[*Approved May 27, 1842.*]**Chapter 115.**

Resolve relating to certain doings of this legislature.

Resolved, That the governor be requested to transmit to the president of the United States, and to the executive of the commonwealth of Massachusetts, copies of the preamble and resolutions passed at this session of the legislature, under the title of “resolves in relation to the north eastern boundary of this state”; and that he communicate also the names of the persons chosen as commissioners by virtue of the said resolves.

[*Approved May 27, 1842.*]**Chapter 116.**

Resolves in relation to the claims of this state for expenditures in protecting its north eastern boundary.

Commissioners
to urge reim-
bursement of
claims against
general govern-
ment.

Resolved, That the commissioners appointed under a resolve passed at this session of the legislature, “in relation to the north eastern boundary of this state,” in conjunction with the executive and members of congress of this state, be authorized and directed to apply to congress, and to insist upon the reimbursement without

delay, by the general government to this state, of the expenditures made under resolves passed January 24, 1839, "relating to trespassers upon the public lands," and February 20, 1839, entitled a "resolve for the protection of the public lands;" and for all the expenditures, both military and civil, made by this state in protecting its territory against threatened foreign invasion, and the trespassers upon our public lands, instigated by an unfounded claim by a foreign power to a portion of our territory; and all other expenditures incurred in carrying on the controversy in relation to the portion of our territory brought into dispute by Great Britain.

Resolved, That the governor be requested to furnish the said commissioners with the proper vouchers for establishing the claims of this state for the expenditures incurred as above stated.

Governor to furnish commissioners with vouchers.

Chapter 117.

Resolve providing for the payment of certain commissioners.

Resolved, That the governor and council be, and they hereby are, authorized to make suitable allowance, out of the contingent fund of the governor and council, to the commissioners chosen under the resolves passed at this session of the legislature, entitled "resolves in relation to the north eastern boundary of this state," the said allowance to be in full for their personal services, time and expenses in discharging the duties of their said commission.

Compensation to commissioners.

Chapter 118.

Resolve in relation to the pay of members of congress.

Resolved, That our senators in congress be instructed, and our representatives be requested to use their influence to procure the passage of a law reducing the pay of members of congress from eight dollars per day to six dollars per day, and the mileage from eight dollars to six dollars for every twenty miles travel.

Resolved, That the secretary of state be requested to forward to each of our senators and representatives in congress a copy of this resolution.
