Chapter 100.

AN ACT to repeal the charter of the Bangor and Brewer Ferry Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The act entitled "an act to establish the Bangor and Brewer charter of the Ferry Company," passed March twenty five in the year of our Lord Bargor and Brewer terry one thousand eight hundred and thirty one, is hereby repealed, and led. its charter annulled.

Chapter 101.

AN ACT to incorporate the Piscataqua Mutual Marine Insurance Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. Thomas Goodwin, 2d, Jedediah Goodwin, John P. Corporators Lord, Samuel Parks, Thomas Jewett, Nicholas Hanson, William A. Young, Richard Waldron, Daniel Pierce and their associates and successors, are hereby created a body corporate by the name of the Piscataqua Mutual Marine Insurance Company, to be estab- corporate name, lished at South Berwick, with power and by that name to prosecute Powers and prive and defend suits at law, to have and use a common seal, to make by laws and regulations for the management of their affairs not repugnant to the laws of this state, to purchase and hold such real and personal estate as may be necessary to effect the objects of their association, and to enjoy all rights and powers, and be subject to all the restrictions and liabilities which are provided for by the seventy sixth and seventy ninth chapters of the revised statutes, in relation to such corporations.

SECT. 2. Every person, who shall at any time become inter- Membership. ested in said company by insuring therein, and also their respective heirs, executors, administrators and assigns continuing to be insured therein as hereinafter provided, shall be deemed and taken to be
