**Chapter 122.**

Resolve in relation to the fine imposed on general Andrew Jackson.

*Resolved*, That it is due alike to the devoted patriotism and distinguished services of general Andrew Jackson, and to the honor of a grateful country, that the fine imposed upon him by judge Hall for an alleged contempt of the authority of the said judge, be unconditionally refunded. Relative to the fine imposed on gen. A. Jackson.

*Resolved*, That our senators in congress be directed, and our representatives be requested, to use their exertions to procure the passage of a law unconditionally refunding to general Andrew Jackson, the fine imposed upon him by judge Hall, together with costs and interest on the same from the day of the payment thereof.

*Resolved*, That the governor be requested to transmit a copy of these resolutions to general Andrew Jackson, to each of our senators and representatives in congress, and to each of the governors of the several states of this Union, with a request that the subject of the same be laid before their respective legislatures.

**Chapter 123.**

Resolve in relation to the disputed territory fund.

*Resolved*, That the governor be requested to apply to the president of the United States, for information whether he has been fur- Relative to the disputed territory fund.

nished with an account of the receipts and payments on account of the disputed territory fund, agreeable to the fifth article of the late treaty with Great Britain; and also, whether the amount due thereon, and any bonds or securities appertaining thereto, have been paid and delivered to the government of the United States. And to request the president, (in case such account, moneys, bonds and securities have been received by the government of the United States,) to transmit to him a copy of said account and memoranda of said securities, with such other information respecting said fund, as he may deem of interest to this state, and proper to communicate.

**Chapter 124.**

Resolves relating to the bankrupt act.

Relative to the repeal of the bankrupt act.

*Resolved*, That the senators in congress from this state, be, and they hereby are instructed, and the representatives requested, to use their constant and continued exertions for the immediate and unconditional repeal of the bankrupt act passed at the extra session of the twenty seventh congress.

*Resolved*, That a copy of the foregoing resolution, signed by the governor, be forwarded by the secretary of state to each of said senators and representatives.

**Chapter 125.**

Resolve in relation to the public lands.

Land agent authorized to permit certain timber.

*Resolved*, That the land agent be, and he is hereby authorized to permit pine timber to be cut on the undivided lands on the St. John's waters, and on the lands belonging to this state on the Aroostook waters, to be sawed into boards or other covering or flooring lumber for the use of the settlers, on those waters within this state; *provided*, that in his estimation the necessities of the settlers on those waters require it. *Provided also*, the whole amount of timber permitted under this resolve shall not exceed five hundred thousand feet.
