And the said deed shall be, and the same hereby is made as valid, to all intents and purposes, as it would be if said conditions had been duly performed.

Resolve providing for the distribution of documents in relation to the sixth census of the United States.

Resolved, That the secretary of state be authorized and directed, For the distribution of docuto distribute the documents containing the copies of the aggregate ments in relation to the 6th census, returns of the sixth census of the United States, forwarded from the department of state at Washington, in the following manner, to wit: one copy of the "enumeration of the sixth census," one copy How distributed. of the "statistics of the United States," and one copy of the "census of pensioners," to each representative district, to be deposited with the clerk of the town containing the largest number of inhabitants; one copy of the "compendium or abridgement of the sixth census," to each of the cities and towns in the state; one copy of each of the above mentioned books to each registry of deeds in the state, for the use of the county; to the library of each incorporated mechanics' association in the state; to the Maine historical society; to the Portland athenœum, and to the Bangor social library; the remainder to be deposited in the state library.

Resolved, That the secretary of state be directed to cause the above documents to be securely packed, enveloped and directed, ready for distribution, previous to the adjournment of the legislature; and that his account for the expense incurred in doing the same, be audited by the governor and council, and that the governor be, and he hereby is, authorized to draw his warrant on the treasury, for the amount that may be allowed for said expenses.
