## CHAP. 195.

## Chapter 195.

Resolve in favor of John Beckwith and others.

John Beckwith  
et. als. discharged  
from bond  
given to the state.

*Resolved*, That the land agent be authorized to cancel and discharge the bond given to the state by John Beckwith, as principal, and Charles McIndoe and Thomas Beckwith, as sureties, on the ninth day of May, in the year of our Lord one thousand eight hundred and forty, for the payment of the sum of two hundred twenty nine dollars and ninety seven cents: *provided* said Beckwith shall pay all costs that have accrued, or may accrue, in consequence of a suit commenced on said bond.

Amount, \$229 97.  
Proviso.

## Chapter 196.

Resolve in favor of John H. Pilsbury and John Webber.

John H. Pilsbury  
and John Webber  
discharged as  
sureties on a cer-  
tain note.

*Resolved*, That John H. Pilsbury, and John Webber, be released and discharged from their liabilities as sureties to the state, on a certain note given by Thatcher and Parker, to the state, dated July eighth, eighteen hundred and thirty one, for the sum of five hundred and forty dollars, and on which the said Pilsbury and Webber were sureties: *provided, however*, that nothing in this resolve shall go to release any claim the state may have against the said Thatcher and Parker, the principal on said note, for their payment of the same.

Proviso.

## Chapter 197.

Resolve in favor of certain soldiers in the town of Ripley.

John G. Jones  
and 16 others  
soldiers in the  
town of Ripley,  
\$3 each.

*Resolved*, That there be paid out of the treasury of the state, to John G. Jones, Joseph H. Perkins, junior, Aaron Randle, Luther Robinson, Josiah Page, junior, Atkins Ellis, junior, Dexter Andrews, Thomas Horn, junior, William Dunlap, junior, Daniel Page, William Bowdoin, Aaron Lord, Daniel B. Bane, John Lane, junior, James S. Carr, Nathaniel Jordan, and Jonathan S. Seavey, the sum of three dollars each, in full for their services rendered the state in the year of our Lord one thousand eight hundred and thirty nine.
