DEAF AND DUMB.—MILITARY PURPOSES.—VALUATION.

Chapter 298.

Resolve relating to certain pupils in the American Asylum for the deaf and dumb.

Resolved, That the sum of five hundred dollars be appropriated, Deaf and dumb, for the purpose of paying arrears for the support of pupils, belonging to this state, at the American Asylum, at Hartford, for the deaf and dumb.

[Approved March 21, 1844.]

Chapter 299.

Resolve making certain appropriations for military purposes.

Resolved, That there be appropriated the sum of two hundred Gun house at and twenty-five dollars, in addition to the proceeds of the sale of the old gun house, to erect a gun house in the town of Clinton. Also the sum of one hundred dollars for the repair of the gun house Gun house in in the town of Calais: and the further sum of fifty dollars for the purchase of harness and repair of ordnance, belonging to the A Artillery at Parls company of artillery, first brigade, sixth division, in the town of Paris, out of any moneys in the treasury of this state, not otherwise appropriated.

Chapter 300.

Resolve equalizing the valuation of the towns of Baldwin and Hiram.

Resolved, That the number of polls set against the valuation of Valuation of Buldwin and Hr. the town of Baldwin, in the county of Cumberland, be one hundred ram equalized. and ninety-two, and the amount of estates set against said town,

CHAP. 301. be one hundred and seventy thousand, six hundred and ninetyseven dollars. And the number of polls set against the town of Hiram, in the county of Oxford, be one hundred and eighty-nine, and the amount of estates be one hundred and twenty-seven thousand, three hundred and eight dollars, instead of the number and sums fixed by the valuation of one thousand eight hundred and forty-one, against said towns. This resolve shall take effect from and after its approval.
