Chapter 193.

CHAP. 193.

AN ACT to incorporate the town of Whitneyville.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. All that part of the town of Machias, in the county of Washington, which is comprised within the following limits, viz: beginning at the southwest corner of said town, and running on the south line thereof eastward, to a point due south from the southwest corner of lot number eighty-two; thence northward to the said corner and on the west line of said lot, to the northeast corner of lot number eighty-three; thence westward on the north line of the lot last mentioned, to the east line of the lot marked O. Smith and J. Kelly; thence northward on the line last mentioned and on the line dividing the lot marked Esquire Jones and Captain O'Brien, to the river; thence straight to the southwest corner of the lot marked Amos Boynton; thence on the west line of the lot last mentioned, to the northwest corner thereof; thence westward to the south line of lot number ninety-three, to the lot marked Jacob Longfellow; thence northward, on the east line of the lot last mentioned, to the southeast corner of lot number ninety-six: thence northward on the east line of the lot last mentioned, to land marked Smith; thence straight to the easternmost corner of lot number ninety-six; thence northward on the line which divides the west range of lots from the adjoining range of lots, to the northeast corner of lot number one hundred and eighteen; thence eastward on the Waterhouse line, so called, to the west line of East Machias; thence northward, on the line last mentioned, to the northeast corner of Machias; thence westward by the south lines of township number eighteen, and of Centreville, to the northwest corner of Machias, as established by Merrit; and thence southward by the west line of Machias, to the place of beginning; reference being had for marks and numbers of lots, to the plan of the township of Machias, taken by Enoch Waterhouse—be set off from the said town of Machias, and, with the inhabitants of the same part, be, and the same hereby is, incorporated into a town, by the name of Whitneyville, with all the powers and privileges which other towns in this state enjoy.

SECT. 2. The said town of Whitneyville shall be held to pay to the inhabitants of the town of Machias, within one year from the time, when notice shall be given by the selectmen of Machias to the selectmen of Whitneyville, of the amount, two ninth parts of all debts and sums of money, which the town of Machias is liable and shall have to pay to any and all persons and corporations, above the avails of all sums now due to said Machias.

Town of Whitneyville incorporated.

Boundary lines.

Powers and privileges.

To pay within one year, &c., two ninth parts of all debts due from the town of Machias, above the debts due to said town.

CHAP. 194.

Division of tax
between Whitneyville and Machias.

SECT. 3. Until another apportionment of state tax shall be made by the legislature, the said inhabitants and estates of Whitneyville shall be held to pay two ninth parts of such state and county taxes, as before this act was passed, would be assessed to the town of Machias; and the town last mentioned shall be held to pay the other seven ninth parts.

Senatorial and
representative
district.

SECT. 4. Until otherwise provided by law, the said inhabitants of Whitneyville shall remain in the same district, for election of senators and representatives, for the state legislature, in which the town of Machias now is.

First meeting,
how called.

SECT. 5. Any justice of the peace, in and for the county of Washington, may call the first town meeting of said town of Whitneyville, for the choice of town officers, and also for other business usually transacted at annual town meetings, by posting up notices thereof in two public places in said town, seven days before such meetings, which notices shall state the time, place and purposes of such meeting; and the same justice of the peace shall preside at such meeting until a moderator shall be, by ballot, chosen.

Chapter 194.

AN ACT to set off Great island from Rome to Belgrade in the county of Kennebec.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Great island set
off to Belgrade.

SECT. 1. That from and after the passage of this act all that part of Rome known as Great island, and situated in what is called Great pond, together with the inhabitants thereon, shall be set off to and become a part of the town of Belgrade, in the county of Kennebec.

To pay to Rome
their proportion
of debts.

SECT. 2. The inhabitants of Great island shall be holden to pay to the town of Rome such proportion of the debts now owing by said town, after deducting therefrom all debts due said town, as the last annual valuation of the inhabitants of said Great island shall bear to the last annual valuation of the inhabitants of said town of Rome.

Inconsistent acts
and parts of acts
repealed.

SECT. 3. That all acts and parts of acts, inconsistent with the provisions of this act, be and the same are hereby repealed.

SECT. 4. This act shall take effect and be in force from and after its approval by the governor.
