AN ACT to set off certain lands from Mount Vernon to the town of Readfield, in the county of Kennehec.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. That from and after the passage of this act, all that Part of Mt. Verpart of Mount Vernon now lying south of the following line, to Readfield. wit: beginning at a point where the north line of Readfield strikes Boundaries. the northwest corner of lot numbered two hundred and thirty, in said town; thence continuing westerly on a line parallel with the north line of lots numbered two hundred and one and two hundred and two, in said town, to the easterly shore of the Greely pond. so called; thence continuing southerly by the easterly shore of said pond, to the present line between said towns of Mount Vernon and Readfield, shall be set off to, and become a part of, the town of Readfield.

SECT. 2. That all acts and parts of acts, inconsistent with the Inconsistent acts provisions of this act, be and the same are hereby repealed.
