SECT. 2. This act shall take effect and be in force from and Inconsistent acts after its approval by the governor; and all acts and parts of acts repealed. inconsistent with the provisions of this act, are hereby repealed.

Chapter 257.

AN ACT to incorporate the Searsmont Cotton and Woolen Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Hazeltine, and their associates and successors, are constituted and made a body politic and corporate, by the name of the Searsmont Cotton and Corporate name. Woolen Manufacturing Company, with all the powers and privi- Powers, privile-ges and liabilileges, and subject to all the duties and liabilities, provided in the ties. laws of this state concerning manufacturing corporations; and are Real and personauthorized to purchase and hold real and personal estate, not exceeding in value at any one time, the sum of two hundred thousand dollars; and the same may improve, lease, sell and convey, as other And said Articles of manproprietors of real and personal estate may lawfully do. company are authorized to carry on in the town of Searsmont, in ufacture. the county of Waldo, the manufacture of cotton, wool and such other materials as may be necessarily or conveniently connected therewith; and may erect and construct such machinery, mills and Machinery, other buildings, as may be useful for that purpose.

SECT. 2. Sumner Pattee and William Keating, or any two of First meeting. the above named persons, may call the first meeting of said company, by publishing a notice of the time and place of said meeting, in any newspaper printed in the county of Waldo, three weeks at least, before the time of said meeting.
