SECT. 18. If the said corporation shall not have been organized, and the location according to actual survey of the route filed with the county commissioners of the counties through which the same shall pass, on or before the thirty-first day of December, in the year of our Lord one thousand eight hundred and fifty, or if the said corporation shall fail to complete said rail road on or before the thirty-first day of December, in the year of our Lord one thousand eight hundred and sixty, in either of the above mentioned cases, this act shall be null and void.

CHAP. 271.

Limitation of time for organizing actual survey of route and completion of said road.

### Chapter 271.

AN ACT to incorporate the Portland Steam Packet Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Lemuel Dyer, William Kimball, Daniel Winslow, Samuel Clark, Nathaniel Blanchard and Moses Gould, their associates, successors and assigns, are hereby created a corporation by the name of the Portland Steam Packet Company, for the purpose of steam navigation between Portland, Boston and such other ports as may be deemed useful, with all the powers and privileges, and subject to all the duties and liabilities, that may be granted and required concerning similar corporations, by the laws of this state.

Corporators

Corporate name.

Powers, privileges, &c.

SECT. 2. The said corporation may take, purchase and hold real and personal estate, to an amount not exceeding at any one time, one hundred thousand dollars, with full power to manage and dispose of the same.

Power to hold real and personal estate.

SECT. 3. Any two persons named in this act, may call the first meeting of said corporation, for the purpose of organizing, at such time and place as they may see fit, by giving notice thereof two weeks successively, in some newspaper published in Portland.

First meeting.
