Chapter 334.

Resolve in favor of Eli T. Sprague.

Resolved, That there be paid out of the treasury of the state, to Eli T Sprague, Eli T. Sprague, of Cooper, eight dollars per month, during the pleasure of the legislature, from the first day of January, in the year of our Lord eighteen hundred and forty-five, in consideration of a severe injury received while on military duty, in July, in the year of our Lord one thousand eight hundred and forty-four.

Chapter 335.

Resolve for the repair of the road from Aroostook road to the town of Smyrna.

Resolved, That the land agent of this state is hereby authorized to Aroostook road, expend a sum not exceeding three hundred dollars, in repairing and &c. improving the road from Aroostook road to the town of Smyrna: provided the commonwealth of Massachusetts will expend an equal amount on said road.

Chapter 336.

Resolve in favor of Isaac Hacker.

Resolved, That the settling duties required by law to be per- In favor of Isaac formed by Isaac Hacker on sections numbered one, two, eight, nine, ten, fifteen, twenty-two, west half of twenty-three, west half of twenty-nine, northeast guarter of thirty-four, and west half and northeast quarter of thirty-five; also on lots numbered twenty-one, twenty-two, twenty-four, twenty-five, twenty-six, twenty-seven, twenty-eight and twenty-nine, in township numbered eleven, in the sixth range of townships west from the east line of the state, be and the same are hereby remitted: provided said Hacker shall have

Снар. 337. cleared and seeded down to grass, in a proper manner, two hundred acres of land in said township, within two years from the passage of this resolve.

Resolve in favor of the town of Casco.

Resolved, That the secretary of state be instructed to purchase and furnish to the town of Casco, all books and reports to which he shall be satisfied said town is entitled by law, provided he shall become satisfied said books and reports have never been furnished to said town.

Chapter 338.

Resolve in favor of Jedediah Fairfield.

Resolved, That the further time of two years be allowed Jedediah Fairfield to erect a grist mill in township number four, in the fifth range of townships west from the east line of the state, agreeably to a resolve entitled a resolve in favor of Jedediah Fairfield, approved March sixteenth, eighteen hundred and forty-three.

Chapter 339.

Resolve for the repair of the Machias Aroostook road.

Machias Aroos took road, \$600.

Resolved. That the land agent of this state is hereby authorized to expend six hundred dollars, for the opening and improvement of the Machias Aroostook road, between the eastern Aroostook or Madawaska road, and the western Aroostook or Fish river road, in township number eleven, range five: provided the state of Massachusetts shall appropriate her due proportion for the above purpose.
