Chapter 348.CHAP. 348.

Resolve in favor of Sylvanus Hatch.

Resolved, That the land agent is hereby authorized and directed to convey to Sylvanus Hatch, lot number twenty-four, in the town of Chester: *provided* he shall pay said agent sixteen dollars and fifty-eight cents within six months from the passage of this resolve.

Chapter 349.

Resolve in favor of Elliot G. Vaughan.

Resolved, That the land agent be directed to release all claim for the payment of money which the state has upon Elliot G. Vaughan, for six lots of land, in the town of Elliotsville: *provided*, the said Vaughan shall release such portion of his claims, upon persons to whom he may have sold any part of said lands, as the land agent may deem just and equitable, if any; and that the land agent be directed to make such distribution of the benefits of this resolve, as the facts in the case may seem to him to require.

Chapter 350.

Resolve in favor of Joseph Williamson.

Resolved, That there be paid out of the treasury of this state, to Joseph Williamson, the sum of thirty dollars, in full for his services as attorney general before the supreme judicial court, held in the county of Waldo, in December, in the year of our Lord one thousand eight hundred and forty-one; the office of attorney general being at that time vacant by the resignation of Daniel Goodenow.

Chapter 351.

Resolve for the improvement of the road from the military road to the mouth of Fish river.

Resolved, That the land agent of this state is hereby authorized to expend a sum, not exceeding three thousand dollars, from the

CHAP. 352.

proceeds of the sales of the public lands, in repairing and improving the road from the military road to the mouth of Fish river: *provided* the Commonwealth of Massachusetts will expend a proportionate sum.

Resolved, That the agent appointed by the land agent to expend the money appropriated by the foregoing resolve, shall render, under oath, a true account of said expenditure to the land agent.

Chapter 353.

Resolve in favor of J. W. Haines.

In favor of J. W. Haines.

Resolved, That the land agent be and he hereby is, authorized and directed to convey to J. W. Haines, six lots of land in township letter D, on the aroostook river, *provided* the said Haines shall, within two years from the approval of this resolve, build a saw mill in said township, clear up ninety acres of land in said township; and put on to his farm, in said township, the following stock, viz: two bulls of the Durham and Hereford breed; six cows and heifers, of the same breed; also a lot of his best breed of sheep and swine; the lots to be selected by the land agent: *provided further*, that the beneficiary of this resolve, or any person owning the mill contemplated to be built, shall not charge for sawing, a sum exceeding two dollars per thousand feet, board measure, for pine timber.

Chapter 353.

Resolve providing for opening and repairing the state road from Blanchard to Moosehead lake.

State road from Blanchard to Moose head lake.

Resolved, That the sum of five hundred dollars is hereby appropriated, and to be paid out of the treasury of the state, for the purpose of opening and repairing the state road from the bridge in the town of Blanchard, to Moosehead lake; three hundred and fifty dollars of which to be expended between said bridge and the public house recently occupied by H. G. O. Barrows, in the town of Wilson, and one hundred and fifty dollars, between said public house and Moosehead lake; and that said appropriation be expended under the direction of the land agent.
