CHAP. 398. forty-six, to be holden by said trustees in their corporate capacity, with full power to manage and dispose of the same in the manner that shall best promote the interests of said academy. Said land to be subject to all reservations provided by law.

Chapter 398.

Resolve additional for payment of accounts against the state.

Resolved, That there be allowed and paid out of any money in the treasury of state, not otherwise appropriated, to the several cities, towns, plantations and persons mentioned in the additional roll of accounts numbered twenty six, the sums set against the names of such cities, towns, plantations and persons respectively, amounting in the whole to the sum of six hundred eighty-four dollars, ten cents, in full discharge of the claims and demands to which they severally refer.

Chapter 399.

Resolve in favor of James White, treasurer of state.

Resolved, That there be paid from the treasury of state, to James White, treasurer, the sum of one hundred and fifty dollars advanced by him to Hartford & Lamson, for binding, and not provided for in the roll of accounts.
