## CHAP. 299.

## Chapter 299.

An additional Act in relation to the Penobscot Boom Corporation.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Committee may  
be appointed pri-  
or to June 1.

SECTION 1. The committee authorized by the first section of an act, additional to an act entitled "an act to incorporate the Penobscot Boom Corporation," approved March twenty-first, one thousand eight hundred and thirty-eight, may be appointed for the present year at any time before the first day of June next, and the committee which shall be so appointed, shall hold their offices until others are appointed in their stead in the manner provided by an act additional to the acts incorporating the Penobscot Boom Corporation, approved April twelfth, eighteen hundred and forty-one.

Tenure of office.

Vacancies, how  
filled.

SECT. 2. Whenever a vacancy may occur in the committee authorized by the aforesaid act, approved March twenty-first, one thousand eight hundred and thirty-eight, the governor and council may appoint a suitable person or persons to fill such vacancy, who shall hold their offices until others are appointed in their stead.

## Chapter 300.

An Act granting proprietors and owners of lands forfeited to the state for non payment of taxes, the right to redeem the same, and further time to pay certain taxes.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Time of redemp-  
tion of certain  
lands extended.

SECTION 1. Proprietors and owners of unincorporated lands forfeited to the state, for the non payment of taxes, or any person or persons interested therein, may redeem the same by paying into the state treasury, the amount of tax for which the same may have been forfeited, together with twenty per cent. interest and such legal costs as may have accrued thereon, at any time prior to the second Wednesday of May, in the year eighteen hundred forty-seven, and not afterwards; and such payment being made as aforesaid, the right and interest of all persons to such lands shall be the same as they would have been, had no such forfeiture occurred as aforesaid.

SECT. 2. Proprietors and owners of unincorporated lands or any person or persons interested therein, on which taxes were assessed by the legislature or county commissioners, in the year eighteen hundred and forty-three, are hereby allowed to pay said taxes, at

any time prior to the second Wednesday of May next, and not afterwards; and every such payment made as aforesaid shall operate in full discharge of such lands from forfeiture to the state by reason of any law in such case made and provided; and all such lands on which said taxes and interest thereon shall not have been paid into the treasury, as required by law, prior to said second Wednesday of May, shall be wholly forfeited and the title thereof shall vest in the state as provided in the ninth section of the fourteenth chapter of the revised statutes.

Otherwise lands to be wholly forfeited.

SECT. 3. This act shall take effect from and after its approval.

Chapter 301.

An Act additional in relation to the Maine Bank.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

The act passed the twenty-second day of March, one thousand eight hundred and forty-three, accepting the surrender of the charter of the Maine Bank, and the act passed the thirteenth day of February, eighteen hundred and forty-five, extending the time for closing up the concerns of said bank: also "an act additional respecting the Maine Bank" passed the sixth day of March, one thousand eight hundred and forty-five, shall continue and remain in force for and during the term of two years from the twenty-sixth day of March, one thousand eight hundred and forty-seven, for the purposes set forth in said acts.

Time for closing up the concerns of Maine Bank, extended.

—two years from March 26, 1847.

Chapter 302.

An Act to incorporate the Sabattis Woolen, and Cotton and Woolen Manufacturing Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*
