Boynton is allowed to take the name of Waterman Kimball and Rebecca Boynton, wife of said Waterman, and Andrew Jackson Boynton and Rebecca Boynton, children of said Waterman and Rebecca, all of Mercer, are allowed to take the name of Kimball as their surname; Nathaniel S. Guptill of Albion, is allowed to take the name of Nathaniel S.
