CHAP. 491.**Chapter 491.**

Resolve for the repair of the road from Fort Kent to the east line of the state.

Repair of road
from Fort Kent
to E. line of the
state.

Resolved, That the land agent is hereby authorized to expend one thousand dollars during the year one thousand eight hundred and forty seven, in opening and repairing the road, (as laid out by the county commissioners), from Fort Kent to the east line of the state; *provided*, that the agent for the state of Massachusetts shall expend an equal sum; *and provided also*, that the inhabitants on said road shall expend an equal sum in labor or materials in improving said road.

Chapter 492.

Resolve abating the taxes on township number six in the ninth range west from the east line of the state.

Abatement of
taxes on No. 6,
R. 9.

Resolved, That the state treasurer be and is hereby directed to abate two third parts of the state and county taxes, for the year one thousand eight hundred and forty-four, assessed on the town aforementioned; and he is also directed to charge the county of Piscataquis with the amount of county tax abated.

Chapter 493.

Resolve in favor of Joel Pelton.

In favor of Joel

Resolved, That the land agent is hereby authorized to convey to Joel Pelton of Madrid, or his assigns, one lot of land equal in amount to those conveyed to revolutionary soldiers and the widows thereof, under former resolves of this state.

Chapter 494.

Resolve in favor of James L. Child.

In favor of James
L. Child.

Resolved, That the governor and council be authorized to examine the claims of James L. Child for services rendered in making

purchases of supplies in Boston for the troops called out in eighteen hundred and thirty-nine for the protection of the northeastern frontier and to allow such further sum in addition to the amount which has been received by him, as they shall deem to be equitable and just, and to draw a warrant on the treasurer therefor.

Chapter 495.

Resolve in favor of James Hersey third and John J. Perry

Resolved, That there be paid to James Hersey third and John J. Perry five dollars and forty cents each, it being the balance due them for services as members of a court martial convened at Bethel in March in the year of our Lord eighteen hundred and forty-four which amount was not allowed in the pay roll of eighteen hundred and forty-five through mistake.

Chapter 496.

Resolve in favor of George Willston.

Resolved, That there be paid out of the treasury of state to George Willston of Brunswick the sum of four dollars per month for one year from the first day of April in the year of our Lord one thousand eight hundred and forty-six for an injury sustained while performing military duty in the service of the state.

Chapter 497.

Resolve providing for the transmission of a certain act to school committees.

Resolved, That the secretary of state be directed to cause the act to establish a board of education to be printed, and to send one copy of the same to the superintending school committee of each town, and the clerk of each plantation in this state.
