are previously paid, he shall proceed to sell to the highest bidder. a CHAP. 92. sufficient quantity of said logs or other timber of the different marks upon the list, to pay such assessments with all proper costs and expenses, selling each mark separately. The place of sale is to be at Place of sale, the office of the company, which office shall be at Bangor, Orono, or Oldtown. And the proceeds of such sales shall be paid into the treasury of the company. And the lien hereby created shall have Lien hereby creprecedence of all other liens, provided however, that if before the ated to have presale it should be ascertained that the logs or other timber of any Proviso, particular mark or marks, had not arrived at their place of destination, but remain back, that in such case said sale may be adjourned from time to time, until such logs or other timber shall arrive at its place of destination.

SECT. 6. Each member of this corporation shall be entitled to Voting. one vote for every six ox team, in any and all meetings of the corporation, and absent members may vote by proxy or substitute.

Every actual lumber operator or land owner on said Members. SECT. 7. east branch and its tributaries, or on the Allegash and Chamberlain lake, above the Grand falls, shall be deemed a member of this corporation during the year or years in which said person or persons are so operating, or continuing to own land as aforesaid, and shall be entitled to all the rights and privileges of said company. Provided Proviso. said operator or land owner shall in writing, signify to said company his desire to be deemed a member of said corporation during the time specified above, and no other class of persons than the aforesaid shall at any time be members of said corporation.

Chapter 92.

An act incorporating the South West Bend Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Edward Little, William Gerrish, Simeon Bailey, John Corporators. D. Spaulding, G. W. Strout, William Gerrish, junior, their associates, successors and assigns, be and they hereby are incorporated and created a body politic by the name of the South West Bend Corporate name Bridge Company with all the powers and privileges and subject to all the liabilities of similar corporations.

Said company are hereby authorized to erect and Authorized to SECT. 2. rect and mainmaintain a bridge across the Androscoggin river, between the towns tain a bridge.

CHAP. 93. of Durham and Lisbon, extending said bridge from the western shore to Great Island, and from said island to the easterly shore of Passage way for said river, and constructing the same so as to leave sufficient passage transportation of timber, &c., to be way for the transportation of timber and the passage of boats, and in such manner as to make the same safe and convenient for the nublic.

Toll granted.

Conditions upon which the powers and privileges conferred by this act are granted.

SECT. 3. Said company shall have the right to demand and receive the same rate of tolls that is by law allowed to the corporation authorized to build a bridge between Lisbon and Durham hereafter referred to.

SECT. 4. The powers and privileges granted by this act are upon the following conditions, viz: that if the existing corporation incorporated by an act entitled "an act incorporating certain persons for building a bridge over Androscoggin river between Lisbon and Durham and for supporting the same," shall prior to the first day of August, eighteen hundred and forty-eight, have proceeded to build a suitable bridge across said river between said towns, so far as to insure its completion by the first day of October, eighteen hundred and forty-eight, then this act shall be void, otherwise it shall be in full force.

Chapter 93.

An act to set off certain lands from Vienna and to annex the same to Chesterville.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

The three lots of land numbered twenty-three, twenty-SECT. 1. four and twenty-five, lying in the town of Vienna, in the county of Kennebec, and adjoining Chesterville, in the county of Franklin, with the inhabitants on the same, are hereby set off from said town of Vienna and annexed to said town of Chesterville.

Valuation of said land to be deducted from Vienna and added to Chesterville.

SECT. 2. The assessors of the town of Vienna may furnish the secretary of state on or before the first day of March next, with a certified copy of the last valuation of the land hereby set off from said town, and the same shall be deducted from the valuation of said town and annexed to the town of Chesterville.
