Chapter 119.

An act to incorporate the South Berwick Steam Manufacturing Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

William Peeker, E. H. Jewett and Bartholomew Wentworth, their associates and successors, are constituted and made a body

Corporate name.

politic and corporate, by the name of the "South Berwick Steam Manufacturing Company," with all the powers and privi-

Powers, privileges and liabilities.

leges, and subject to all the duties and liabilities provided in the laws of this state concerning manufacturing corporations; and are authorized to purchase and hold real and personal estate, not exceeding in value, at any one time, the sum of one hundred thousand dollars; and the same may improve, lease, sell and convey, as other proprietors of real and personal estate may lawfully do. And said company are authorized to carry on at South Berwick, in the county of York, the manufacture of wood, iron and steel; and may erect and construct such buildings and machinery as may be necessary and useful for that purpose.

Chapter 120.

An act to revive the charter of the Great Works Bridge, and to grant further time for the construction thereof.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Act approved March 23, 1839, revived.

SECT. 1. An act entitled "an act to incorporate the proprietors of the Great Works Bridge," approved March twenty-third, eighteen hundred and thirty-nine, is hereby revived, and the further time of five years from the passing of this act is hereby allowed for the construction of said bridge.

Five years allowed for the construction of said bridge.
First meeting.

SECT. 2. Any one of the persons named in the first section of said act may call the first meeting of said proprietors by giving notice in the manner prescribed in said act, and this act shall take effect from and after its approval by the governor.
