#### CHANGE OF NAMES.

SECT. 3. Any two of the persons named in this act, may call the first meeting of said corporation at such time and place as they may see fit, by giving notice of the same for two weeks successively in some newspaper published in Portland, for the purpose of organizing said corporation.

### Chapter 138.

An act to change the names of certain persons.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Douglass; Lewis Cross, of Bluehill, shall be allowed to take the name of Lewis Parker; Levi Witham, Ann Bethiah Witham, John Henry Witham, George Francis Witham, and Alphonzo Witham, all of Jackson, shall be allowed severally to take the surname of Howard; James H. Roach, of Portland, shall be allowed to take the name of James H. Laroche; Abraham S. Flye, of Sedgwick, shall be allowed to take the name of Charles S. Flye; Joseph Weeks, junior, of Portland, shall be allowed to take the name of Joseph Lemuel Weeks; Elizabeth Jane Montgomery, of Hallowell, shall be allowed to take the name of Elizabeth Montgomery; Thomas Farnham, of Bath, shall be allowed to take the name of Thomas L. Farnham; William Nash, third, of Waldoborough, shall be allowed to take the name of William French. And said persons from and after the passage of this act shall be known and called by the names which they are respectively allowed to take as aforesaid; and the same shall be hereafter considered as their only true and proper names.
