Chapter 156.

An act to incorporate the Trustees of the Union Academy at Oldtown.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Samuel Pratt, Silas Stow, Solomon Moulton, Samuel H. Merrill, Lorenzo Leadbetter, Rufus D. Folsom, Ephraim B. Peirce, William H. Smith, their associates, successors and assigns, are hereby constituted a corporation by the name of the Trustees of the Union Academy at Oldtown, and by this name may sue and be sued; have a common seal; make such by-laws, not repugnant to the laws of this state, as they may deem expedient for the management of their affairs; fill all vacancies occurring in their number; take and hold real and personal estate that they may now possess or may hereafter receive, by donation or otherwise, the annual income of which shall not exceed two thousand dollars, said income to be faithfully applied to promote the cause of education; and the trustees aforesaid are intrusted with all the powers and privileges incident to similar corporations.

SECT. 2. This act shall take effect from and after its approval by the governor.

SECT. 3. The first meeting of the trustees shall be called by Ephraim B. Peirce, by giving each incorporator a written notice of the time and place of meeting, seven days at least prior thereto.

Chapter 157.

An act to incorporate the Trustees of Limington Academy.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. John H. Garmon, Isaac Mitchell, George Small, Robert Brackett, Joshua W. Frost, Gideon L. Moody, Sewall Thompson, Israel S. Hopkinson, Isaac Dyer, Edward Clark, Richard Meserve and Moses E. Sweat, their associates, successors and assigns are hereby constituted a corporation by the name of the Trustees of Limington Academy; and by this name may sue and be sued; make such by-laws as they may deem expedient for the management of their affairs; fill all

vacancies occurring in their number; take and hold any estate real and personal, that they may now possess or may hereafter receive by donation or otherwise, the annual income of which shall not exceed two thousand dollars; said income to be faithfully applied to promote the cause of education; and the trustees aforesaid are invested with all the powers and privileges incident to similar corporations.

SECT. 2. Any two of said corporators are authorized to call the first meeting of the corporation, by posting up, in two or more public places in Limington aforesaid, notices therefor, ten days at least before the time appointed for said meeting.

SECT. 3. This act shall take effect and be in force from and after the approval of the same by the governor.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Nichols, Green Cram, Gardner Dennett, Theodore M. Bradbury, Thomas Cram, Joshua Paine, junior, and James W. Emery, their associates and successors are hereby constituted a corporation by the
