#### Chapter 89.

CHAP. 89.

Resolve rescinding a resolve approved March twenty-third, eighteen hundred and thirty-eight.

Resolved, That a resolve approved March twenty-third, eighteen hundred and thirty-eight, entitled "resolve in favor of education" is hereby rescinded and annulled.

#### Chapter 90.

Resolve abating the tax on Number Two, Oxford county, south of Rumford,

Resolved, That the state treasurer is hereby directed to abate Cortain taxes the state and county taxes for the years one thousand eight hundred and forty-five, six, seven, and eight, assessed on the aforementioned number two, and he is also directed to charge the county of Oxford, with the amount of county tax abated.

#### Chapter 91.

Resolve correcting the valuation of the county of Oxford.

Resolved, That the aggregate valuation of the county of Valuation of Ox-Oxford be four million eighteen thousand thirty-six dollars, instead of the sum now fixed to said county respectively by the resolve approved April fourth, eighteen hundred and forty-The above abatement is by reason of number two south of Rumford, being incorporated into two plantations by the names of Franklin and Milton.

#### Chapter 92.

Resolve in favor of the trustees of Somersct Academy,

Resolved, That the land agent of this state is hereby authorized to conized and directed to convey to the trustees of Somerset Acad-vey to said acad-way to said acad-way to said agent authorized to convey to said agent age emy, one quarter township of land situated in the county of township of land.

Value.

Proviso.

Aroostook, said land to be selected by the land agent and to be equal in value, as near as may be, to one half of the east half of township number three in the fourth range of townships in the county of Aroostook; the land agent in estimating the value of the land to be granted, shall have reference to the value of the above named land at the time it was conveyed to the trustees of the Lee Normal School; provided however, that the land agent shall not make the conveyance herein provided, unless he shall be fully satisfied on or before the first Monday of October, in the year one thousand eight hundred and fortynine, that the trustees applying for such grant shall have furnished a good academical building; shall have commenced a school in said building, and shall have corporate property at least to the amount of one thousand dollars over and above the debts of the corporation.

#### Chapter 93.

Resolve in favor of certain members of the legislature who visited the state prison.

Appropriation for expenses.

Resolved, That there be paid out of the treasury of the state the following sums, to wit: to Benjamin B. Thomas, six dollars and fifty-three cents; to James H. Farnum, six dollars and fifty-three cents; Henry E. Dyer, six dollars and fifty-three cents; Samuel T. Hinds, six dollars and fifty-three cents; David Knapp, six dollars and fifty-three cents; members of the legislature appointed to visit the state prison by a vote of the legislature passed July twentieth, eighteen hundred and forty-eight.

#### Chapter 94.

Resolves relating to portions of school funds belonging to certain plantations.

Treasurer of Aroostook to refund to state treasurer sundry portions of school funds apportioned to unincorporated places,

Resolved, That the treasurer of the county of Aroostook is hereby authorized and directed to repay to the treasurer of state the sum of six hundred thirty-four dollars and forty-eight cents, being the aggregate of sundry portions of the annual school funds heretofore apportioned for the benefit of inhabitants of
