An act to incorporate the Norway Liberal Institute.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Corporators.

SECT. 1. Franklin Manning, Ezra F. Beale, Benjamin Tucker, junior, Horatio G. Cole, Isaac Bradbury, Luther F. Pike and Lorenzo Hathaway, their associates, successors and assigns, are hereby constituted a corporation by the name of the trustees of Norway Liberal Institute ; and by this name may sue and be sued ; have a common seal ; make such by-laws, not repugnant to the laws of this state, as they may deem expedient for the management of their affairs ; fill all vacancies occurring in their number ; take and hold real and personal estate that they may now possess or may hereafter receive by donation or otherwise, the annual income of which shall not exceed two thousand dollars, said income to be faithfully applied to promote the cause of education ; and the trustees aforesaid are intrusted with all the powers and privileges incident to similar corporations.

First meeting.

SECT. 2. The first meeting of the trustees may be called by either of the corporators above named, by giving each incorporator a written notice of the time and place of meeting, seven days at least prior thereto.

SECT. 3. This act shall take effect from and after its approval by the governor.

### Chapter 207.

An act to incorporate the Great Pond Mining and Agricultural Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Corporators.

SECT. 1. John D. Buzzell, George W. Smith, their associates, successors and assigns, are hereby incorporated into a company by the name of the Great Pond Mining and Agricultural Company, for the purpose of cutting and manufacturing peat, mining iron and other minerals, and cultivating cranberries and other agricultural products, on lands now owned, or on adjoining lands, which hereafter may be owned by said company, in the town of Cape Elizabeth ; and for that purpose, may construct and maintain a dam or dams at the outlet and

inlet, or on any part of their premises, at or above the original outlet of the pond, called the "Great Pond," for the purpose of overflowing the same or the bogs adjoining, or any part thereof, to the same height as heretofore used and enjoyed by the owners of the mill privilege upon the said waters.

SECT. 2. Said company may engage in any other branch of business or trade, which may be necessary to aid in carrying on the business aforesaid, with power to hold real and personal estate, not exceeding at any one time, one hundred thousand dollars, and the same, or any part thereof, to sell, lease or convey at pleasure.

SECT. 3. The company shall have all the privileges and be subject to all the duties and liabilities contained in the seventy-eighth chapter of the revised statutes, and such other acts, relating to corporations, as are now in force in this state; *provided however*, that the property belonging to said corporation shall be exempt from all assessments and taxes for the term of five years from and after the passage of this act.

Privileges, duties and liabilities.

Proviso.

SECT. 4. Any one of the persons named in this act shall have power to call the first meeting of said company, by giving personal notice of the time and place of said meeting to each of the other corporators, fourteen days at least before said meeting.

## Chapter 208.

An act to incorporate the Somerset Flax and Hemp Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled*, as follows:

Andrew McFadden, Franklin Smith, Samuel Gould, P. M. Foster, John Pierce and William R. Flint, together with their associates and successors, are hereby constituted and made a body corporate and politic by the name of the Somerset Flax and Hemp Company, with all the powers and privileges, and subject to all the duties and liabilities provided in the laws of this state concerning manufacturing corporations; and they are hereby authorized to hold and use a capital of twenty thousand dollars.
