## Chapter 246.

An act to incorporate the Saco River Bank.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

SECT. 1. Oliver Dow, Tobias Lord, Ebenezer Adams, William T. Boulter, James L. Emerson, George W. Lord, Silas Elden, Martin Foss, Noah Rendell, James Morton, Joseph Hobson, Albert G. Bradbury, Jeremiah Hobson, Abel Smith, John Falls, Stephen P. Lane, Moses K. Wells, Edward Peabody, George Gilman, Aaron Clark, junior, Nathaniel I. Miller, E. B. Usher, Samuel P. Gaty, Caleb R. Ayer, George Chadbourn, William L. O'Brien, Joshua T. Lincoln, John Jameson, Edwin W. Wedgwood, S. P. Small, Simon Brown, junior, and their associates, successors and assigns, are hereby incorporated into a company by the name of the President, Directors and Company of the Saco River Bank.

Corporators.

Corporate name.

SECT. 2. The capital stock of said bank shall be fifty thousand dollars, divided into shares of one hundred dollars each. And said bank shall be located and established in West Buxton village, in the town of Buxton, in the county of York.

Capital stock.

Location.

SECT. 3. Said corporators are hereby authorized and empowered to exercise all the rights and privileges conferred upon such corporations by the laws of this state, and subject to all the liabilities and restrictions thereof.

## Chapter 247.

An act to set off a part of the town of Hanover and annex the same to the town of Bethel.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

All that part of the town of Hanover, lying south of Bear river, is hereby set off from said town of Hanover and annexed to the town of Bethel. And the said Bear river shall hereafter be the boundary of said town of Hanover, from the point where the line of said town now crosses said stream, to the Androscoggin river.
